NOVEMBER 23, 2009

Wabash County Commissioners met in regular session in the Wabash County Courthouse on Monday, November 23, 2009. Chairman Brian Haupert called the meeting to order at approximately 9:00 A.M. with all members present: Brian K. Haupert, Scott E. Givens, and Barry J. Eppley. The proceedings of the meeting were recorded by Wabash County Auditor Jane Ridgeway. The minutes of the November 16, 2009 meeting were reviewed. Eppley made a motion to approve the minutes as written; his motion was seconded by Givens and passed with a 3-0 vote.

State Representative, William Ruppel:

- 1. Stated that Wabash County is one of seventy (70) counties in Indiana with on time tax billing. Ruppel gave his praise for keeping on top of the requirements.
- 2. Informed Commissioners that the Federal Highway Administration has approved \$313,000 for the North Manchester Covered Bridge restoration project which includes any phase up to 80% of the cost. Also, the Historic Covered Bridge Fund has awarded \$592,000 for the North Manchester covered bridge fund.
- 3. Requested that INDOT consider repaying SR 114 east of North Manchester in 2010 rather than 2011. This is under review.
- 4. Spoke with INDOT regarding revisiting the widening and repaving of SR 16 from SR 19 to the Wabash/Huntington County line. A re-study has been done by INDOT showing an increase in heavy trucks on this road. The traffic has increased from an average of 200 per day to over 300 per day which is mostly semi and grain trucks going to POET. Ruppel stated the road is also very narrow. This will be a very expensive project due to moving utility poles and the need to purchase land for the widening. This is under review.
- 5. County Attorney Downs inquired whether Ruppel could look into an issue with a petition submitted for a review and a stay on an order from the State on the 800 N railroad crossing to install activated gates. Downs stated we have been granted the stay while it is under review, but there has been no contact. Ruppel stated he would investigate.
- 6. Stated he also has requested INDOT to consider widening Cass Street. This is under review.
- 7. EMA Director Brown stated, regarding SR 16, a commodity flow study has just been completed for the entire county and he would be glad to share the data. Brown also stated part of their mitigation plan is working on SR 16 from county line to county line and offered this data as well. Ruppel thanked Brown for the information.
- 8. Ruppel thanked Commissioners, Auditor and other officials for all their hard work.

Phil Amones, Highway Superintendent:

1. Presented a request from Verizon to bury cable at 1000 N east of 300 E.

2. Presented a certified letter from Verizon stating they are going to make a claim on 400 S just west of SR15 where a guy wire was hit by a county mower causing the telephone line to sag and ultimately to be pulled from the house.

Steve Hicks, Major Chief Deputy Sheriff, stated the average daily population in the jail last week was 70.4.

Steve Downs, County Attorney was present with nothing to report.

Bob Brown, EMA Director:

- 1. Requested to use available funds to purchase ten (10) rain coats for EMA volunteers that are water resistant, NC3 compliant, have a parka, and have reflective stripping. The coats are around \$130 each for a total of \$1,300. Commissioners unanimously agreed.
- 2. Stated he has submitted the application for the CCP grant.
- 3. Has signed and submitted the Indiana Emergency Response Commission (IERC) paper work for the annual hazardous material matching grant through LAPC. This funding is used for training, planning, and exercise.

Mike Howard, Plan Commissioner, requested permission to purchase a new copier/scanner. Howard stated it would cost \$300 to repair the current machine. Howard stated a quote for a new machine from Indoff Inc totaled \$379 and \$397 from Staples. Howard stated the funds are available. Givens made a motion to approve purchase of a copier/scanner from Indoff Inc totaling \$379; his motion was seconded by Eppley and passed with a 3-0 vote.

Jim Dils, County Coordinator:

- 1. Stated there is a problem with the heating/cooling system in the courthouse. One actuator broke and will need to be replaced; also two valves need to be repacked. The total cost for the repairs is estimated to be \$3,000-3,500. Dils stated Havel Brothers will complete the repairs.
- 2. Has received the annual clock maintenance agreement. Dils stated he is negotiating the cost of the agreement.

Jane Ridgeway, Auditor:

- 1. Stated the DLGF has done the first review of our budget and all looks good. A second review is expected this week. Ridgeway stated she is hopeful to have approval on our budget right after the Thanksgiving Holiday.
- 2. Presented the Maximus annual cost allocation plan contract agreement. Commissioners will take under advisement while contract is reviewed by Attorney Downs.

Jeff Kumfer and Mary Ellen Rudisel-Jordan, Scearce Rudisel Architects:

- 1. Presented three (3) proposals for the west door entrance of the courthouse. Givens stated EMA Director Brown is looking into a keyless entry at that entrance and will need to be taken into consideration. Commissioners requested a 3-D rendering of the proposals presented.
- 2. Presented three (3) proposals and decorating samples for the renovation of the Commissioner's meeting room. Commissioners will take under advisement.
- 3. Discussed the next step on the window façade; starting on the west side of the building in the spring. Commissioners set January 11th at 10:00 for receiving window bids for the windows on the west side of the courthouse.
- 4. Dils discussed the idea of window dressings. Dils stated he had received a quote from SLA Design for all the windows on the south side of the building; 1 inch blinds would cost \$4,137.64 and 2 inch blinds would be \$5,678.82 this is purchased and installed. Dils stated there would be an extra cost of \$1,318 and \$1,522.40 respectively to include blinds above the transom. Dils also stated they had found a set of fourteen (14) shutters in the attic but not all are usable and they are not matching sets. Haupert requested a cost on shutter options. Kumfer stated he would obtain that information.
