

November 3, 2014

The Wabash County Board of Commissioners met in regular session in the Wabash County Courthouse on Monday, November 3, 2014. Chairman Scott E. Givens called the meeting to order at 9:00 a.m. with three members present: Givens, Brian K. Haupert and Barry J. Eppley. The proceedings of the meeting were recorded by Wabash County Auditor Linda Conrad. The minutes of the October 27, 2014 meeting were reviewed. Haupert made a motion to approve the minutes as written. Eppley seconded the motion; it passed by a 3-0 vote.

John Martin, County Highway Superintendent stated that county Attorney Steve Downs has reviewed the annual bids that were opened last week and found a few irregularities, but these can be waived. They were:

1. Camdon did not include a non-conclusion affidavit in the second bid which replaced a previous bid. The first bid was not opened so the affidavit could be in the first bid packet. The first bid packet was opened and the affidavit was included.
2. North Central submitted only one non-conclusion affidavit instead of three; one for each bid.
3. Debco Metal Culvert neglected to sign their non-conclusion affidavit and the bid. Carol Bucher was present and signed the affidavit and bid.

Eppley made the motion to waive all irregularities with the three bids. Haupert seconded the motion; it passed by a 3-0 vote.

Haupert made the motion to accept all the bids submitted. Eppley seconded the motion; it passed by a 3-0 vote.

Sheriff Bob Land reported the Wabash County Jail currently has 83 inmates with 17 inmates at the Miami County Jail. The peak population was 88.

Jim Dils, County Coordinator was present with nothing to report.

Linda Conrad, Wabash County Auditor presented:

1. Accounts payable claims and allowance docket for 11/03/2014
2. Payroll claims and allowances for the pay period ending 10/25/2014
3. Resolution amending the resolution which created the Wabash County Tourism Commission. Hauptert made a motion to approve Resolution 2014-85-12. Eppley seconded the motion; it passed by a 3-0 vote.
4. Ordinance 2014-85-18 amending the Rainy Day Fund, which was approved by the county council on October 27. It also requires approval from the commissioners. Eppley made a motion to approve the amendment. Hauptert seconded the motion; it passed by a 3-0 vote.

Beverly Ferry, CEO, Living Well in Wabash County CoA, Inc. presented:

1. Contract from INDOT the 2015 Section 5311 Capital Assistance Grant for signatures. The grant is for Rural Public Transportation. The budget for the grant is \$76,825. The local match is 20% or \$15,365 and 80% or \$61,461 is from federal monies. Living Well is now searching for local match funds.
2. Contract from INDOT the 2015 Section 5311 Operating Grant for signatures. The total grant is for \$611,968; the local match is \$256,947.

Most of these funds are through local governments, in-kind donations, and grants.

With no other business to come before the Board of Commissioners the meeting was adjourned. The commissioners will meet on Monday, November 10, 2014 in the commissioners' room on the second floor of the Wabash County Courthouse.
