The Wabash County Board of Commissioners met in regular session in the Wabash County Courthouse on Monday, May 6, 2024. Chairman Jeff D. Dawes called the meeting to order at 9:00 a.m. with all commissioners present: Dawes, Brian K. Haupert and Barry J. Eppley. The proceedings were recorded by Wabash County Auditor Marcie Shepherd. The minutes of the April 29, 2024, meeting were reviewed. Haupert made a motion to approve the minutes as written. Eppley seconded the motion; it passed by a 3-0 vote.

First on the agenda was the appointment of Eileen Sklar to the North Manchester Public Library Board. Haupert made a motion to appoint Eileen Sklar to the Board. Eppley seconded the motion; it passed by a 3-0 vote.

Ryan Baker, Wabash County Sheriff, presented:

- 1. Medical contract with Quality Correctional Care for the jail. Baker reported the County Attorney has reviewed the contract and approved it. Eppley made a motion to approve the contract. Haupert seconded the motion; it passed by a 3-0 vote.
- 2. Requested medical shelving to hold inmate medical records. Baker stated the shelves which were purchased were not the correct type to hold these records without them falling over. The commissioners requested the Sheriff obtain two quotes.
- 3. Quality Correctional Care has requested a medical chair so they can perform dental work. Eppley made a motion to approve the purchase of a chair for \$1,995.00. Haupert seconded the motion; it passed by a 3-0 vote.
- 4. Requested filing cabinets for sex offender files, both active and inactive. Baker would like to purchase from Uline for uniformity in the file cabinets with the rest of the building. Haupert made a motion to approve the purchase. Eppley seconded the motion; it passed by a 3-0 vote.
- 5. Baker stated radios are needed in the jail due to some dead areas. Kosciusko County has radios and repeaters they are getting rid of and he would like to purchase those. Additional equipment will be needed that can be purchased from J&K Communications. Eppley made a motion to approve the purchases from both Kosciusko and J&K for a total of \$12,836.40. Haupert seconded the motion; it passed by a 3-0 vote.

Marcie Shepherd, Wabash County Auditor, presented:

- 1. Accounts payable claims and allowances for docket ending 05/06/2024. Eppley made a motion to approve the claims and allowances as presented. Haupert seconded the motion; it passed by a 3-0 vote
- 2. Payroll claims, allowances and withholdings for pay period ending 04/27/2024. Eppley made a motion to approve the claims. Haupert seconded the motion; it passed by a 3-0 vote.
- 3. The 2024 May LIT Distribution for \$1,475,186.34 to all taxing units. Eppley made a motion to approve. Haupert seconded the motion; it passed by a 3-0 vote.
- 4. The 2024 Commercial Vehicle Excise Tax Distribution for \$113,895.00 to all taxing units. Eppley made a motion to approve. Haupert seconded; it passed by a 3-0 vote.
- 5. Bond request for payment #39 for \$421,118.07. Haupert made a motion to approve the payment. Eppley seconded the motion; it passed by a 3-0 vote.

Dawes asked if there were any ADA or Title VI concerns; none were heard.

Haupert made a motion to adjourn the meeting. Eppley seconded the motion; it passed by a 3-0 vote. The Commissioners will next meet on Monday, May 13, 2024.
