September 9, 2024

The Wabash County Board of Commissioners met in regular session in the Wabash County Courthouse on Monday, September 9, 2024. Chairman Jeff D. Dawes called the meeting to order at 9:00 a.m. with Dawes, Brian K. Haupert and Barry J. Eppley present. The proceedings were recorded by Wabash County Auditor Marcie Shepherd. The minutes of the September 3, 2024 meeting were reviewed. Eppley made a motion to approve the minutes as written. Haupert seconded the motion; it passed by a 3-0 vote.

PUBLIC HEARING: Petition to vacate a portion of ground in the north half of Section 14, Township 29 North, Range 6 East in Pleasant Township and being more particularly described as follows: All that portion of County Road 150 West lying between the north line of County Road 950 North and the south line of County Road 1000 North in Pleasant Township. Brian Campbell, Area Plan Director, along with Kurt Kurtzhals and Joe Vogel requested to vacate the ground described above. With no comments from the public, Eppley made a motion to approve the vacate with Ordinance 2024-85-04. Haupert seconded the motion; it passed by a 3-0 vote. Haupert made a motion to suspend the rules and proceed to second reading. Eppley seconded the motion; it passed by a 3-0 vote. Haupert made a motion to approve Ordinance 2025-85-04 on second reading. Eppley seconded the motion; it passed by a 3-0 vote.

Mark Frantz, Wabash County Attorney presented Ordinance 2024-85-05 regarding security for the Wabash County Judicial Center. Frantz explained the ordinance will give the security personal something to hand out if questioned about the rules of the building. Haupert made a motion to approve Ordinance 2024-85-05. Eppley seconded the motion; it passed by a 3-0 vote. Eppley made a motion to suspend the rules and proceed to second reading. Haupert seconded the motion; it passed by a 3-0 vote. Eppley made a motion to approve Ordinance 2025-85-05 on second reading. Haupert seconded the motion; it passed by a 3-0 vote.

Cole Wyatt, County Highway Superintendent presented a utility permit from NIPSCO to expand the main at 1042 W 500 N. Haupert made a motion to approve the permit. Eppley seconded the motion it passed by a 3-0 vote.

Tyler Guenin, Chief Deputy Sheriff, presented the August 2024 jail report. Total prisoner counts 157, female prisoners housed 31, male prisoners housed 126. There were 88 prisoners booked, 20 transports, 32 DNA collection, and 22 fingerprints were ordered by the courts.

Marcie Shepherd, Wabash County Auditor presented:

- 1. Accounts payable claims and allowances for docket ending 09/09/2024. Eppley made a motion to approve the claims and allowances as presented. Haupert seconded the motion; it passed by a 3-0 vote.
- 2. Payroll claims and allowances plus withholdings for pay period ending 08/31/2024. Eppley made a motion to approve the claims. Haupert seconded the motion; it passed by a 3-0 vote.
- 3. Riverboat distribution in the amount of \$113,441.37. Haupert made a motion to approve the distribution as presented. Eppley seconded the motion; it passed by a 3-0 vote.
- 4. The September LIT distribution for \$1,475,186.34 to be disbursed to the county taxing units. Eppley made a motion to approve the distribution. Haupert seconded the motion; it passed by a 3-0 vote.

Dawes asked if there were any ADA or Title VI concerns; none were heard.
