DECEMBER 22, 2008

Wabash County Commissioners met in regular session in the Wabash County Courthouse on Monday, December 22, 2008. Chairman Scott Givens called the meeting to order at approximately 9:00 A.M. with two (2) members present: Brian K. Haupert and Scott E. Givens. The proceedings of the meeting were recorded by Wabash County Auditor Jane Ridgeway. The minutes of the December 15, 2008 meeting were reviewed. Haupert motioned to approve the minutes as written; his motion was seconded by Givens and approved by a 2-0 vote.

Phil Amones, County Highway;

- 1. Amones reported on a meeting with the State last week regarding St Rd 124. The State is set to accept bids in December and start construction soon thereafter.
- 2. Amones presented the Engineering Phase Contract with United Consulting on Bridge #645, the North Manchester Covered Bridge. The total cost of this portion of the project is \$121,000.00. Wabash County's portion of this cost is not to exceed \$24,200.00. The contract was reviewed and approved by County Attorney Steve Downs. Commissioners signed contract.
- 3. Amones updated Commissioners on the 1400 N land owner meeting. Amones stated the land owner had agreed to move to the next step which would be to obtain an appraisal on the land. Commissioners agreed and asked Amones to obtain appraisals.

Steve Downs, County Attorney;

- 1. Downs stated he is working with POET and the County Auditor to insure the current invoice reimbursement payment from them is done by the end of the year.
- 2. Downs stated he had reviewed the contract with EAGL regarding the collect of docket fees presented at last week's meeting by Clerk of the Courts Lori Draper. Downs stated there were a few minor changes. Haupert motioned to approve contract with EAGL with Downs recommended changes; his motion was seconded by Givens and passed with a 2-0 vote.

Jim Dils, County Coordinator was present with nothing to report.

Lori Draper notarized the County Auditor's Official Bond for the new term.

Kelly Schenkel, Assessor, presented contracts for next year's trending and new construction. These are the two (2) types of assessing done by the Assessor's Office yearly. Commissioners stated contracts need to be reviewed by Downs.
