MAY 3, 2010

Wabash County Commissioners met in regular session in the Wabash County Courthouse on Monday, May 3, 2010. Chairman Barry J. Eppley called the meeting to order at 9:00 A.M. with all members present: Eppley, Brian K. Haupert and Scott E. Givens. The proceedings of the meeting were recorded by Auditor Jane Ridgeway. The minutes of the April 13th Executive Session and the April 26, 2010 meeting were reviewed. Haupert made a motion to approve both as written; his motion was seconded by Givens and passed with a 3-0 vote.

Phil Amones, County Highway Superintendent, stated there will be a change order in the works on the Dora Road project. They will be using a smaller aggregate mix.

Bob Brown, EMA Director,

- 1. Reported INdigital will be here today to check cable placement.
- 2. Stated J&K will be installing antennas over the weekend.

Kathryn Carter-Lower Health Department Deputy Registrar/Office Manager & Lynn Dannacher Health Department Environmental Food Specialist, requested permission for the Health Board to add three (3) new fees to the current Health Department Ordinance:

- 1. Farmers Market retail food establishments set up at the Farmers Market will be charged \$25.00 per season/per location
- 2. Any retail food establishment or annual permit holder requiring additional permits will be charged a fee of \$25 per truck or mobile, per year
- 3. Any name or address changes to the original permit will cost \$10 and a new permit will be required

Dannacher stated this was passed by the Health Board at their last meeting. Haupert made a motion to approve the added fee schedules amending the WCHD Ordinance; his motion was seconded by Givens and passed by a 3-0 vote. Carter-Lower stated this information will be placed on the Health Department website. County Attorney Steve Downs stated he would draft a revised ordinance and present it at the May 10th meeting.

Steve Downs, County Attorney:

- 1. Stated there were two (2) inmates transferred to Miami County for safe keeping. This transfer is not a part of the proposed contract agreement for housing inmates in Miami County.
- 2. Forwarded a draft of the Central Dispatch Ordinance for EMA Director Brown to review
- 3. A contract between Wabash City and the county on the same is in the works.

Jim Dils, County Coordinator, presented three quotes for mowing and lawn care service for the southern slope of the courthouse property from Wabash to Miami Street:

Dils stated each submission included a Certificate of Insurance. Services would be provided approximately once per week. Auditor Ridgeway stated this could be paid from the Courthouse Lawn Care budget line item. Haupert made a motion to accept Nate's Lawn Care at \$65 for the south slope only; his motion was seconded by Givens and passed by a 3-0 vote.

- 4. Requested approval for a Tax Refund due to a change in assessment: Honeycutt, Johnny A. & Patsy A. \$57.04. *Commissioners approved and signed the claim.*

At 9:30 A.M., As advertised, Eppley called a Public Hearing to address the request by the Wisler Mennonite Church in Disko to vacate an alley. The request is to vacate a 16.5 foot wide alley lying east of SR 114 north of lots 43, 44, 45, 46, 47, south lots of 26, 27, 28, 29 and 30 located in the northeast ¼ of the southwest quarter of section 35, township 30N, range 5E. Residents Mark Eberly, Wayne Weaver and Plan Commission Director Mike Howard presented a map of the location, required advertisements, mailings and returned signatures from neighbors east of the location. Howard stated this alley has not been vacated on the current plat map. Each adjoining property owner will be given ½ of the property. Givens made a motion to vacate the alley in Disko; his motion was seconded by Haupert and passed by a 3-0 vote. Downs stated he will draft an Ordinance and present at next week's meeting.
