The Wabash County Board of Commissioners met in regular session in the Wabash County Courthouse on Monday, July 11, 2016. Chairman Barry J. Eppley called the meeting to order at 9:00 a.m. with all commissioners present: Eppley, Scott E. Givens and Brian K. Haupert. The proceedings were recorded by Wabash County Deputy Auditor Marcie Shepherd. The minutes of the July 5, 2016 meeting were reviewed. Givens made a motion to approve the minutes as written. Haupert seconded the motion; it passed by a 3-0 vote.

John Martin, County Highway Superintendent presented:

Steve Downs, County Attorney presented Ordinance 2016-04-85 amending the Rainy Day Fund. Haupert made a motion to approve the ordinance. Givens seconded the motion; it passed by a 3-0 vote. Haupert made a motion to suspend the rules and proceed to second reading. Givens seconded the motion; it passed by 3-0 vote. Givens made a motion to approve the ordinance on second reading. Haupert seconded the motion; it passed by a 3-0 vote.
