The Wabash County Board of Commissioners met in regular session in the Wabash County Courthouse on Monday, December 16, 2019. Chairman Barry J. Eppley called the meeting to order at 9:00 a.m. with all Commissioners present: Brian K. Haupert and Jeff D. Dawes. The proceedings were recorded by Wabash County Auditor Marcie Shepherd. The minutes of the December 9, 2019 meeting were reviewed. Haupert made a motion to approve the minutes as written. Dawes seconded the motion; it passed by a 3-0 vote.

Beverly Ferry, CEO Living Well in Wabash County COA, requested updated signatures for the 5311 Grant. Due to not getting the 2020 vehicle pricing as expected, the signature page needed to be updated. No pricing in the grant has changed. Haupert made the motion to approve the signature page. Dawes seconded the motion; it passed by a 3-0 vote.

Eppley presented Resolution 2019-85-11 for approval.

RESOLUTION AUTHORIZING APPLICATION SUBMISSION AND LOCAL MATCH COMMITMENT

RESOLUTION OF THE BOARD OF COMMISSIONERS OF WABASH COUNTY, INDIANA, AUTHORIZING THE SUBMITTAL OF THE FY 2019 EDA DISASTER SUPPLEMENTAL GRANT APPLICATION TO THE FEDERAL ECONOMIC DEVELOPMENT ADMINISTRATION AND ADDRESSING RELATED MATTERS

WHEREAS, the Board of Commissioners of Wabash County, Indiana recognize the need to stimulate growth and to maintain a sound economy within its corporate limits; and

WHEREAS, the Board of Commissioners of Wabash County, Indiana has identified needs for workforce development and wishes to pursue a project known as the Heartland Career Center Project;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Wabash County, Indiana that:

- 1. The Board of Commissioners President (currently, Barry Eppley) is authorized to prepare and submit an application for grant funding to address a workforce development project, and to execute and administer a resultant grant including requisite general administration and project management, contracts and agreements pursuant to regulations of the Economic Development Administration and United States Department of Commerce. The grant amount being requested is \$4,000,000.00
- 2. The Board of Commissioners of Wabash County, Indiana hereby commits the requisite local funds in the amount of One Million dollars (\$1,000,000.00), in the form of a bank loan obtained by Heartland Career Center for said program, such commitment to be contingent upon receipt of Disaster Supplemental funding from the Economic Development Administration. These funds are readily available and unencumbered.

Adopted by the Board of Commissioners of Wabash County, Indiana this 16^{th} day of December, 2019, at 9:00 AM.

Haupert made the motion to approve Resolution 2019-85-11. Dawes seconded the motion; it passed by a 3-0 vote.

Dawes seconded the motion; it passed by a 3-0 vote. Haupert made the motion to suspend the rules to proceed to a second reading. Dawes seconded the motion; it passed by a 3-0 vote. Haupert made the motion at approve Ordinance 2019-85-11 on second reading. Dawes seconded the motion; it passed by a 3-0 vote.

Cole Wyatt, County Highway Superintendent, presented:

- 1. Commitment letters for Bridge 110 (500 S over Treaty Creek) and Bridge 652 (market Street over Eel River). Haupert made the motion to approve both commitment letters. Dawes seconded the motion; it passed by a 3-0 vote.
- 2. Requested to approve the all the annual bids that were received (December 9, 2019) except for one Traffic Control Specialist, due to missing documents. Haupert made the motion to approve all bids, except for Traffic Control Specialist. Dawes seconded the motion; it passed by a 3-0 vote. The approved bids are attached as a separate document at the end of these minutes.

Ryan Baker, Wabash County Sheriff, reported that the Wabash County Jail currently has 86 inmates, with 41 additional being housed in the Miami County Jail and 31 in the Elkhart County Jail. Last week there were 24 book-ins and 17 transports to other facilities. The peak population was 90. The total inmate count was 159.

Keith Walters, County EMA Director, was present with nothing to report.

Mark Frantz, County Attorney representative, was present with nothing to report.

Jim Dils, County Coordinator/HR Director, presented an amendment to the IT contract with Intrasect Technologies. No changes were made to the terms or amounts; just the addition of language the State requested to be included. Haupert made the motion to approve the amendment. Dawes seconded the motion; it passed by a 3-0 vote.

Marcie Shepherd, Wabash County Auditor, presented the 2020 Contractual agreement between Purdue Extension and Wabash County for Purdue Extension Educators. Haupert made the motion to approve the contract. Dawes seconded the motion; it passed by a 3-0 vote.

With no other public comment or other business to come before the Board of Commissioners, the meeting was adjourned. The commissioners will next meet on Monday, January 6, 2020.
