Haupert called the meeting to order at 9:00 a.m. with all commissioners' present: Haupert, Barry J. Eppley, and Jeff D. Dawes. The meeting was held in person and via Zoom. The proceedings were recorded by Wabash County Auditor Marcie Shepherd. The minutes of the April 27, 2020 meeting were reviewed. Dawes made a motion to approve the minutes as written. Eppley seconded the motion; it passed by a 3-0 vote.

Cole Wyatt, County Highway Superintendent, presented:

- 1. Ordinance 2020-85-05 Regulating Traffic on County Highways (Servia stop and speed limit signage) for approval. Eppley made a motion to approve the ordinance. - 3. Stated Bridge 701 repairs have been completed and it is open to the public.

- 2. The 5311 Grant reimbursement report for the first quarter on behalf of Living Well. Eppley stated transit is taking the necessary precautions due to the virus to ensure the safety and well being of the riders and drivers. The FTA traditional funding has switched to the CARE Act. Eppley signed the reimbursement report.
