The Wabash County Board of Commissioners met in regular session in the Wabash County Courthouse on Monday, December 20, 2021. Commissioner Jeff D. Dawes called the meeting to order at 9:00 a.m. with all three commissioners present: Dawes, Barry J. Eppley and Brian K. Haupert. The proceedings were recorded by Wabash County Auditor Marcie Shepherd. The minutes of the December 13, 2021 meeting were reviewed. Haupert made a motion to approve the minutes as written. Eppley seconded the motion; it passed by a 3-0 vote.

Christa Stroup, Circuit Court Reporter requested permission to apply for the 2022 Court Interpreter Grant thru the Indiana Supreme Court. The court has two jury trials for which the defendants will require interpreting services. The grant request is for \$25,000. Stroup said the grant is reimbursable and they have been using the funds left from the 2019 grant. Haupert made a motion to approve the grant to be sent to Council for approval. Eppley seconded the motion; it passed by a 3-0 vote.

Geoff Schortgen, Purdue Extension Director, reported the 2022 Purdue Extension Contract (Nov. 8, 2021) has been reviewed by the county attorney and is ready to be submitted to Purdue. Schortgen stated that if the commissioners have any questions about the various programs provided, he would be happy to answer them.

Cole Wyatt, County Highway Superintendent, presented a request from MSD of Wabash to put stone in a driveway at 3220 E 400 S. Haupert made a motion to approve the request. Eppley seconded the motion; it passed by a 3-0 vote.

Ryan Baker, Wabash County Sheriff, reported the jail currently has 85 inmates, with 17 additional being housed in the Miami County Jail, and 29 in the Tipton County Jail. Last week there were 24 book-ins and 7 transports to other facilities. The peak population was 89. The total inmate count was 130.

Keith Walters, County EMA Director, was present with nothing to report.

Steve Downs, County Attorney:

- 1. Asked if the commissioners would like a RFQ (request for qualifications) sent out concerning a possible sewer district for Urbana, Northcliff and Speicherville. The commissioners agreed that sending out an RFQ would be appropriate.
- 2. Presented a Declaration of Partial Vacation of the ARC Light Business Park Plat. This vacation would not change any of the covenants to the plat. Eppley made a motion to approve the declaration. Haupert seconded the motion; it passed by a 3-0 vote.

Jim Dils, County Coordinator/HR Director, was present with nothing to report.

Marcie Shepherd, Wabash County Auditor, presented:

- 1. Payroll claims and allowances for pay period ending 12/11/2021. Haupert made a motion to approve the claims. Eppley seconded the motion; it passed by a 3-0 vote.
- December Settlement for \$12,687,075.14 to all taxing units. Haupert made a motion to approve the settlement. Eppley seconded the motion; it passed by a 3-0 vote.

Old Business: The commissioners requested an additional appropriation for \$50,000 to support Waypoint Woman's Center (Nov. 22, 2021). During the December 13, 2021 Council meeting, the Council voted to table the appropriation until the ARP plan is completed. Eppley made a motion for the \$50,000 to come out of the EDIT funds. Haupert seconded the motion; it passed by a 3-0 vote.

Review Items: Ford Meter Box – office of air quality - modification at an existing source.

The meeting was held in recess until 2 p.m. for the new Sheriff Office and Jail Phase 3 bid opening.

At the advertised time, Dawes called the meeting back to order for the opening of the bids. Haupert made a motion to close the bids. Eppley seconded the motion; it passed by a 3-0 vote. The following bids were received:
