The Wabash County Board of Commissioners met in regular session in the Wabash County Courthouse on Monday, April 8, 2024. Chairman Jeff D. Dawes called the meeting to order at 9:00 a.m. with all commissioners present: Dawes, Brian K. Haupert and Barry J. Eppley. The proceedings were recorded by Wabash County Auditor Marcie Shepherd. The minutes of the April 1, 2024, meeting were reviewed. Eppley made a motion to approve the minutes as written. Haupert seconded the motion; it passed by a 3-0 vote.

Brian Swihart, Chief Probation Officer, requested permission to apply for one Court Services and six Community Corrections grants. Eppley made a motion to approve submitting applications for these grants. Haupert seconded the motion; it passed by a 3-0 vote.

Cole Wyatt, Wabash County Highway Superintendent presented:

- 1. A right of way permit from Heartland (TWN) for county wide fiber optic installations. Haupert made a motion to approve the utility permit. Eppley seconded the motion; it passed by a 3-0 vote.
- 2. A right of way permit from Sweetser Telephone to install new service at 1370 W 1200 S. Eppley made a motion to approve the utility permit. Haupert seconded the motion; it passed by a 3-0 vote.
- 3. A right of way permit from Frontier for Precision Utilities Group to install new service to 856 W Waterworks Road. Eppley made a motion to approve the utility permit. Haupert seconded the motion; it passed by a 3-0 vote.

Marcie Shepherd, Wabash County Auditor, presented:

- 1. Accounts payable claims and allowances for docket ending 04/08/2024. Eppley made a motion to approve the claims and allowances as presented. Haupert seconded the motion; it passed by a 3-0 vote.
- 2. Payroll claims and allowances including withholdings for pay period ending 03/30/2024. Eppley made a motion to approve the claims. Haupert seconded the motion; it passed by a 3-0 vote.
- 3. The 2024 April LIT Distribution for \$1,475,186.34 to all taxing units. Eppley made a motion to approve the distribution. Haupert seconded the motion; it passed by a 3-0 vote.

Dawes asked if there were any ADA or Title VI concerns; none were heard.

Haupert made a motion to adjourn the meeting. Eppley seconded the motion; it passed by a 3-0 vote. The commissioners will next meet on Monday, April 15, 2024.
